DEPOSIT

A deposit of \$150 is required to reserve wedding date. This is **non-refundable**. The \$150.00 payment can be paid by credit card, cash, or check. Due to the nature of the business, your wedding date will not be held until a deposit is paid and a contract is received. Your deposit will be deducted from the wedding day balance, which will be due on your wedding day. The day of your wedding we will also accept credit card, cash, or check. Only ONE form of payment will be received day of services. Please warn all bridesmaid ahead of time. We will only be cashing on ONE person with ONE form of payment, this will ensure as easy quick transaction.

ADDITIONAL FEES

20% gratuity will be added to the final total.

CANCELLATION POLICY

Cancellations can be made up to 90 days before the wedding day without any extra charges. If you cancel 30 days prior to your wedding day 50% of the total wedding date rate quote will be charged to credit card provided. If you cancel 14 days or less of the wedding day you will then be charged 100% of the total wedding day rate quoted.
